## **EMPLOYER DESCRIPTION**

The Laborers' and Retirement Board Employees' Annuity and Benefit Fund of Chicago (the "LABF") was established in 1935 for the purpose of providing retirement and disability benefits to employees of the City of Chicago or the Board of Education who may be employed in a laboring capacity and to the beneficiaries of such employees. Employees of three City of Chicago pension funds are also members of the LABF. The LABF is governed by an eight-member Board of Trustees and currently employs approximately 20 full-time staff members. ### JOB DESCRIPTION

Under the general direction of the Staff Actuary & Senior Developer, the Benefits Data Analyst & Developer plays a key role within the Benefits Department and is responsible for a broad range of benefits-related calculations, data analysis, auditing and system development/programming functions.

### Key Duties and Responsibilities:

System Development:

- Utilize all aspects and functionality of Microsoft Office's Excel, Word, and VBA programming for automation of standard procedures and reports
- Develop queries and scripts with Microsoft Server T-SQL
- Learn all aspects of legacy Pension Administration Database System, as it applies to current administration procedures; assist with developing improved processes, features and functionality
- Assist, train and mentor users with respect to all office technology and software solutions
- Serve as technical liaison between the LABF and vendors

Benefits Administration:

- Apply appropriate methodology for calculating benefits, years of service, and various service credits available to members
- Review and analyze information to accurately determine retirement and disability benefits, benefit estimates, service credit, vested benefits, refunds and other related information
- Work with other Illinois public pension funds for the purposes of calculating reciprocal benefits
- Maintain knowledge of current and proposed Illinois statutes which affect the Fund, as well as IRS-approved procedures as necessary for rollovers and other tax issues

Assist with and perform other duties as assigned

*Education:* Bachelor's Degree (minimum GPA of 3.2/4.0)

**Experience**: Minimum of 3 years of work experience preferred in computer programming, database administration, defined benefit plan administration, retirement benefits administration, or related field. Experience developing database queries (particularly using SQL), performing data analysis in Microsoft Excel and/or programming in Visual Basic. Experience in the areas of actuarial science or web development a strong plus.
