# LABF IS MOVING OFFICES ON JAN. 5, 2026

# **NEW OFFICE LOCATION: 150 N. WACKER DR. SUITE 800**

After 15 years at 321 N. Clark St., our current lease will be coming to an end. Our last day in the current office will be Friday, January 2, 2026. Our first day at the new office at **150 N. Wacker Dr. Suite 800, Chicago, IL 60606** will be **Monday, January 5, 2026**.

The new office location is not far from our current office, and we feel it will continue to serve our members well. While our next office will look nice and new, we are proud to report that it will be a substantial savings to the Fund – savings that will be reinvested in the pool of assets that pay for members' hardearned benefits.

Although our physical office location will change, our current phone numbers, email addresses, and other general forms of communication will not change. Any mail sent to LABF <u>prior</u> to January 5, 2026 should continue being sent to 321 N. Clark St. Ste. 1300. Any mail sent <u>on or after</u> that date should be sent to 150 N. Wacker Dr. Ste. 800. LABF will have all mail forwarded to the new address for at least 12 months after the move so that any mail sent to our prior address will reach us at our new address.

**GETTING THERE:** The new building is located at the northwest corner of N. Wacker Dr. and W. Randolph St., with the main entrance/lobby located on N. Wacker Dr., and is easily accessible by public transit.



If you choose to drive, you may pay for valet guest-parking, available on a first-come first-served basis at the northeast corner of the building (accessed by heading southbound on Upper Wacker Dr.), or various street parking and parking garage options nearby. Please note that construction has begun on the Lake Street Bridge over the Chicago River, which is closed to vehicles and pedestrians, and is expected to be completed in January 2028.

To access the building, enter the 1<sup>st</sup> floor lobby on N. Wacker Dr. and present a photo ID to the security desk to your left. As always, notifying LABF in advance of your planned visit will help us ensure your visit is as easy as possible.

Northern Trust Benefit Payment Participant Web Passport® is a multi-faceted portal that allows LABF members immediate and secure access to their program information 24/7. LABF members will be able to self-enroll, access real-time account information as well as historical tax statements, obtain on-the-spot payment status (paid vs. outstanding), and review payment history. The portal will not include any disability or lump-sum refund payment information, which will be readily available through LABF.

This web portal is intended to provide members with easier access to their information, and signing up is optional. Please be on the look out for further enrollment instructions enclosed with your December 1<sup>st</sup> annuity earnings statement.
