Market Tracker

Mr. Wesner reviewed the Market Tracker Report for February 28, 2023.

February 28, 2023 Preliminary Performance Report

Mr. Wesner reviewed the Fund's February 28, 2023 Preliminary Performance Report.

Follow-up to Special Investment Meeting

March 21, 2023

Mr. Wesner advised of a correction to the Asset Allocation Study presented by Marquette at the March 9, 2023 Special Investments meeting. A footnote incorrectly stated that cashflows were included in the analysis. He stated that Marquette would issue a revised Asset Allocation Study for the Fund's records.

Mr. Oliver relayed responses from Baillie Gifford to questions that the Board asked at the Special Investment Meeting held on March 9, 2023 regarding lack of diversity and volatility in the portfolio. The Trustees requested additional follow-up regarding Baillie Gifford's response regarding diversity.

The Board inquired about a previous question they had regarding the diversity plans from Victory Park Capital (VPC), one of LABF's investment managers. Mr. Oliver reported to the Board on several new DEI initiatives that have been implemented by VPC. The Board requested additional information regarding those new initiatives. Mr. Oliver also noted improved diversity statistics regarding VPC's recent hiring of professional level employees.

ADMINISTRATIVE REPORT

Concentra Contract

Ms. Consola reviewed an updated contract with Concentra, the company LABF uses for Fund physician services, and reported that Concentra raises it standard prices each year. Prices under the Fund's new contract would be increased from \$54 per exam to \$57 per exam. Ms. Consola noted that the new price is still lower than the rate of the Fund's previous physician and is in line with what Concentra charges their other clients. She requested approval from the Board to execute the new contract. The Trustees raised concerns about certain provisions of the contract and asked if those concerns could be addressed in the new contract.

It was moved by Trustee Capasso, seconded by Trustee Crivellone, to approve the new contract with Concentra, subject to potential changes to address the Trustees' concerns to be negotiated by Ms. Consola and Mr. Muzzy.

Write-Off Approval

Ms. Consola requested Board approval for specific cases to be written off pursuant to LABF's Recoupment Policy. She stated that the LABF is unable to collect on the specific cases for various reasons. Ms. Consola explained that the LABF currently uses multiple services to monitor and provide death notifications to the Fund and that LABF has improved its collection process. The Trustees asked questions about the cases and LABF's processes for recoupment, which Ms. Consola reviewed.

It was moved by Trustee Skardon, seconded by Trustee Capasso, to approve the write-off of the specific accounts as recommended by Fund staff and the Fund's collection law firm.

Employee Resignation – Ms. Consola informed the Board that Paul Rzsezutko, the Fund's Benefits Manager, had resigned and his last day would be March 29, 2023. She thanked him for his years of hard work, expertise and dedication to the Fund.

Statement of Economic Interests – Ms. Consola informed the Trustees that they should have received an email from the Cook County Board of Ethics regarding the filing of their annual statements. Ms. Consola noted that the due date for the completed statements is May 1, 2023.
